ATPI Alerts Travel Opportunities per Country during Coronavirus (COVID-19)

Dear Valued Client,

Countries all over the world are implementing travel bans and restrictions in an effort to limit the spread of the COVID pandemic outbreak. Below you may find the most recent updates in short. Note that unexpected travel cancellations are taking place and airlines status may change at any given time without prior notice. The enlisted information are based on the officially announced governmental travel restrictions and quarantine measures.

Below is a summary of the latest updates, please be aware it is not a complete overview of all current travel bans and restrictions.

General Important Notes:

- Own face coverings / masks will be required across all airports and flights, to comply with COVID-19 measures.
- It is strongly advised to arrive as early as possible to the airport for your departure.
- Airlines have their own policies which are being updated regularly and can be checked directly on their respective websites.
- For the latest information about local country restrictions we advise to check the website of Ministry of Foreign Affairs

Areas & airports opening or softening restrictions

EUROPEAN COUNTRIES:

- **Europe:** Update: Austrian government lifts COVID-19-related restrictions for all of its neighboring countries except Italy
- **Montenegro:** Update: Two international airports reopen for commercial traffic; first scheduled flights announced for 8 June
- **U.K.:** Update: Commercial flights will return to London City Airport by end of June
- **Belgium:** Update: Government will reopen businesses on 8 June, borders on 15 June
- **Albania:** Security Message: U.S. Embassy reports commercial flights expected to resume beginning 15 June

- **Ukraine:** Update: Domestic flights will resume from 5 June
- **Denmark, Finland, France, Lithuania:** Update: Lithuanian government to resume flights to France, Finland, Denmark
- **France, Portugal, Spain:** Update: Spanish government to reopen land borders with France and Portugal from 22 June
- **Turkey:** Update: Government plans to gradually resume flights with 40 countries in June

ASIAN / AUSTRALIAN COUNTRIES:

- **United Arab Emirates:** Update: Government allows opening of airports for limited flights
- **China, U.S.:** Update: Chinese government will allow some barred airlines to fly into mainland starting 8 June

AIRLINES:

- United Arab Emirates: Update: **Emirates** will resume transit flights to 29 destinations from 15 June after government lifts suspension
- Europe: Update: **Jet2** releases full list of destinations as it braces to resume flights from 1 July
- Oman: Update: **Oman Air** prepares to resume services
- Australia, New Zealand: Update: **Qantas, Air New Zealand** to increase domestic flights following COVID-19 related cancellations
- United Arab Emirates: Update: **Etihad Airways** to resume transit flights from 20 cities from 10 June
- Europe: Update: **Croatia Airlines** to resume seven additional routes 15-21 June

Areas & airports imposing further restrictions

- **Hong Kong:** Security Message: U.S. reissues its travel concerns because of COVID-19, advises increased caution
- **Burkina Faso:** Security Message: U.S. Embassy reports curfew has ended for some areas, state of emergency continues in several provinces
- **Spain:** Update: Government extends state of emergency until 21 June
- **Costa Rica:** Security Message: U.S. Embassy reports some COVID-19 restrictions lifted, border remains closed through 30 June

AIRLINES:

- Indonesia: Update: **Lion Air** suspends domestic, international flights until further notice because passengers not following COVID-19 regulations
- Bangladesh: **Biman Bangladesh Airlines** cancels all flights on 3, 4 June because of low number of passengers; flights set to resume on 5 June
