ATPI Alerts Travel Opportunities per Country during Coronavirus (COVID-19)

Dear Valued Client,

The world is still changing by the hour during this COVID pandemic outbreak. Many travel bans are being eased or lifted and other countries still extend or expand their current travel bans. Airlines slowly start up their network again, although with lower capacity. Our 3-weekly update informs you in short about the latest information.

India/Maharashtra exemption on PCR test

Please note that as per the latest advisory issued by the Govt. of Maharashtra, all arriving passengers (both international and domestic) having **a valid certificate of vaccination and having taken the second dose at least 15 days prior to travel**, will be exempted from carrying a negative RT-PCR report. Important to note that the passengers must carry a valid certificate issued through the COWIN portal to seek exemption.

Areas & airports opening or softening restrictions

AREAS & AIRPORTS:

- **U.K.:** Most COVID-19 rules in Wales will end from 7 August; Scottish government plans to lift most legal restrictions on 9 August
- **Czech Republic, France, Russia:** Update: Russian authorities to allow resumption of flights with Czech Republic and France from 24 July
- **Global:** Update: U.K. government to add Croatia, Hong Kong and Taiwan to country's COVID-19 green travel list.
- **Mauritius:** Update: Borders reopen for international travelers

AIRLINES / TRAIN:

- **Gambia, Nigeria, Senegal:** **Air Peace** to resume flights between Lagos and Banjul, Dakar on 23 July

Areas, airlines & airports imposing further restrictions

AREAS & AIRPORTS:

- **Global:** Update: U.K. government to add Indonesia, Myanmar, Sierra Leone to COVID-19 red travel list.
- **South Korea:** Update: Authorities extend COVID-19 restrictions outside capital region
- **Zimbabwe:** Update: Government extends COVID-19 Level 4 lockdown by two weeks; inter-city travel remains banned
- **Spain, U.K.:** U.K. government adds Balearic Islands, Ibiza, Majorca and Minorca to COVID-19 amber travel list
- **Brazil, India, Peru, South Africa:** Update: Peruvian authorities extend suspension of flights from Brazil, India and South Africa between 16-31 July because of COVID-19
- **Australia:** Update: Authorities impose 5-day COVID-19 lockdown on Victoria state after increase in cases
- **Australia, New Zealand:** Update: Quarantine-free travel between Victoria state and New Zealand to be paused from 16 July because of increase in COVID-19 cases
- **Portugal:** Update: Government extends COVID-19 restrictions to wider area of country

AIRLINES / TRAIN:

- **Global:** Update: **TUI** releases its latest list of flights and holidays canceled through 31 July because of COVID-19 restrictions
