ATPI Alerts Travel Opportunities per Country during Coronavirus (COVID-19)

The world is still changing by the hour during this COVID pandemic outbreak. Many travel bans are being eased or lifted and other countries still extend or expand their current travel bans. Airlines slowly start up their network again, although with lower capacity. Our 3-weekly update informs you in short about the latest information.

Areas & airports opening or softening restrictions

AREAS & AIRPORTS:

- Oman: Flights to resume between Sohar Airport and Salalah Airport after suspension because of COVID-19
- Argentina: Update: Authorities announce relaxation of some COVID-19 lockdown restrictions on citizens; government expected to reopen borders for vaccinated foreigners
- Cambodia, India: Cambodian authorities will lift ban on travelers from India from 7
 August after fall in new COVID-19 cases

AIRLINES / TRAIN:

- United Arab Emirates, U.K.: Emirates will resume flights between Dubai and Glasgow from 11 August
- India, U.K.: Air India to begin direct flights from Kochi to London starting 18 August with three COVID-19 tests still required for unvaccinated passengers

Areas, airlines & airports imposing further restrictions

AREAS & AIRPORTS:

- **Vietnam**: Update: Authorities to extend strict COVID-19 restrictions in Hanoi until 22 August following detection of new cases
- Philippines: Authorities impose two-week lockdown in Manila because of COVID-19
- Global: German authorities declare southern France, French overseas territories COVID-19 high-risk area; Netherlands removed from list
- Norway: Update: Government extends its advice against non-essential travel to other countries until 1 September because of COVID-19

- Brunei Darussalam: Government reinstates COVID-19 restrictions for two weeks following detection of new cases
- North Macedonia: Government introduces mandatory vaccination certificate starting from 16 August
- China: Update: Beijing Daxing International Airport announces suspension of flight routes from 15 cities because of COVID-19
